Safety and Security Technology enhancements

- Creation of online safety training for staff utilizing the PHM website
- P-H-M Website with "School Safety" information and tips for parents and public
- Utilization of electronic forms for safety, security and emergency drill reporting
- Merged existing analog camera system with new digital video mega pixel cameras creating a district wide digital video system and storage solution.
- Created an emergency operational command center at the Educational Services Center
- Installed a digital repeater and established an emergency radio frequency for Penn-Harris-Madison School Corporation.
- Creation of new security office and camera room at Penn High School.
- Planned and implemented an emergency exit monitoring system for Penn High School and fitness center.
- Created, trained and implemented procedures for video surveillance.
- Installed the Digital Video System client on Dean of Student workstations at PHS.
- Integrated the Enterprise Building Integrator security system with the Digital Video Management system for optimal utilization of existing equipment.
- Planned and created a Digital Video Management Emergency System for real time responses in crisis situations and alarm calls.
- Utilization of VPN security capabilities to remotely access the security system for school closing, delays days or alarm issues.
- *Utilization of Android tablets for remote security system access and video management.
- Investigated, evaluated and implemented a district wide Parent Notification System. School Messenger was approved in August 2012 and implemented in November 2012.
- Upgrade the Digital Video Management system with enhanced capabilities from an analytical and integration to EBI systems in November 2012.
- Upgrade the EBI equipment and software to latest version in November 2012.
- Planned role out of Elementary School Digital Video Management systems to replace the stand alone analog systems in each building. Summer 2013
- Phase III upgrade of Digital Video Management system at Schmucker and Grissom Middle Schools. Summer 2013
- Replacement of 10 old analog cameras at Penn High School. Summer 2013

- Implementation of 911 location call programming. Identification of location of 911 call and text notification.
- Utilization of Honeywell's DVM R500 version software for enhanced video review and overall operations.
- Updated P.A. systems in all schools will integrate with the VOIP systems being put in place by technology. Enhanced digital communications for emergency announcement protocols.
- 911Inet / eTileline (Secured Public Safety Network) to enable secured communication for District Crisis Team in a large scale emergency. Permits secured connections to local police, fire, Emergency Management and other response agencies.
- Purchase of Digital Video Management ready workstations and software for key personnel within district as part of the Indiana Secured Grant
- Purchase of a laptop for security to enable remote digital video capabilities and emergency management communications
- Replaced 17 Security workstations (EBI stations) in all school locations across district with an all-in-one unit that includes a touch screen monitor system.
- Phase II implementation to enhance the Digital Video Management system at Discovery Middle School Summer 2015
- Systematic upgrade to the Digital Video Management system at Penn High School to replace analog cameras with digital. Summer 2015
- Expand the panic button range at Penn High School during summer 2015 by adding access points and remote panic buttons.
- Implementing an audio recording messaging component for emergency notifications at Penn High School. This will be an addition to the simplex fire system model 4100.
- Created a new Maintenance and Food Service radio frequency to break out this traffic from the daily bus communications. This frequency is on our Transportation Tower and emergency frequency.
- Layer 2 of our security corridors is being expanded in summer 2016 to include the café and gym doors in all elementary locations.
- Additional AED units have been purchased for PHS, DMS, SMS, GMS, NP and MF locations.
- Security Bollards for entrances at Penn High School.
- 15 digital cameras will replace old analog cameras at Penn High School 2016
- Additional cameras are being placed at Transportation Center, Northpoint, Elsie Rogers, Mary Frank, Moran, Elm Road, Discovery, Grissom, Schmucker, Madison, Walt Disney during summer 2106
- Security LED lights are planned for Elm Road and Moran Elementary
- Radio batteries will be replaced as needed in all locations
- Landscape shrubbery will be planted in various school locations considering CPTED in an effort to deter vandalism among our school locations

Safety and Security procedures

- Installed numeric keypad card readers at all locations hosting Kids Club programs. Parents can access the building by numeric code while maintaining a locked facility.
- Implemented school lockdown procedures during school hours for all P-H-M Schools. All visitors must be viewed and accepted into the office by school office personnel.
- Installed panic or holdup buttons for all school offices.
- Established a Crisis Team at all school locations based on the Crisis Prevention Institute's Non-Violent Physical Crisis Intervention Training.
- Established a Sporting Events Crisis Manual, Food Service Crisis Manual and Transportation Crisis Manual.
- Conducted a Transportation tabletop exercise developing procedures and involved local fire departments and online training in classrooms.
- Implemented Kids Club cash audit guidelines and procedures.
- Established a security committee at Penn High School.
- Organized and established procedures for K9 searches at Penn High School.
- Established a physical division of Penn High School utilizing gates to reduce or eliminate traffic in the south section after 4:30pm nightly.
- Registration of small electronics via an electronic form at Penn High School.
- Coordination of Adult Education classes on north side of Penn High School when possible to maintain security and safety.
- Implemented an elementary school traffic program utilizing program assistants and other traffic control components for student drop-off and pick-up.
- Penn High School campus traffic improvements at main entrance, Jefferson Road and Schmucker Middle School.
- Implementation of new drug testing program involving urine testing for students.
- Activation of New Avenues Agreement to provide counseling services in the event of an emergency crisis in which our P-H-M staff, students and patrons need intervention.
- Installation of the Raptor Visitor Management System in the front offices of each school location for school year 2013-14.
- Addition of three panic or holdup remote buttons for each school office.
- Incorporation of a three layer approach to security that involves a master panic button that will close all doors and corridors in a lockdown.
- Emergency Plan flip charts created for all classrooms across the district.
- Safe School Helpline created for a third party anonymous reporting of bullying, suicide or threat reporting.
- Addition of HIRON to assist with crisis communications within district
- Completed a traffic study of schools by coordinating with DLZ engineers
- Implemented a staggered student pickup procedure at Moran as a Pilot program.
- Implemented the staggered approach and fully executed the new traffic flow of Moran Elementary.

- Addition of 10 digital cameras to Grissom Middle School spring 2013.

 - o Layer 1 Offices
 - Layer 2 Coridors

- Phase II of the security corridors for Middle and High School beginning summer 2014.

- Controlled gate access for the Support Services Center to include gate access and card readers, video cameras, digital intercom system for deliveries.
- Upgrade of the Penn High School intercom system to include 4 additional entry points along with digital handsets and software to manage door access.
- Completed the middle and high school corridors along with remote panic hold up devices at each location. All schools now have layer two (2) installed.
- DLZ has completed a traffic study and plans have been shared to implement a parallel road on Beech next to Moran Elementary during summer 2015.
- DLZ study suggested improvements to Walt Disney parent traffic. Signing and striping of pavement will take place in Spring 2015.
- Moved, installed and configured the Grissom Middle School Radio antenna to the Transportation Center. PHM now has redundant radio towers for district communication for bus, maintenance and emergency frequencies.
